Science for democracy

'Science for democracy' is a seven-day project of the Center for Interdisciplinary Polish Studies of the European University Viadrina for ten young scientists from six EaP countries. The project aims at developing of existing participants' skills and takes place from 6th to12th December 2015 in Berlin and Frankfurt (Oder).

During the project the young scientists will visit various think thanks (e.g. German Institute for International and Security Affairs, German Council on Foreign Relations DGAP, political foundations, Evangelical Academy Berlin, European Academy Berlin) and other scientific institutions that are either occupied with consulting for the state institutions or with activities regarding the development of civil society.

Participants will get to know how democracy works in Germany using the example of self-administration, civic engagement and volunteering, public consultations or referendum. They will discuss which solutions can be implemented in their countries and which obstacles are in place. Possible solution approaches will be developed and analyzed in mixed scientific teams. The participants will be also mentored by one mentor for two participants to make use of the newly established contacts and to disseminate the knowledge learnt after the end the project.

Participants

Diana Bencheci, PhD, born in 1978, is an Associate Professor at the University of Chisinau. Her research interests include military conflicts, conflict resolution and other issues related to international relations. She is about to open one of the first university-based think-tanks in Moldova. The aim of the think-tank will be providing decision-makers with excellent research-based analysis and policy recommendation concerning Moldavian foreign and domestic policy. The focus of this think-tank would be on conflict resolution. She is additionally involved in work of a youth organization International Centre for Cooperation in Education and Research in Moldova and is searching for German partners. In this context, she is also interested in the issue of civic engagement and civic participation in public policy more generally.

Angela Bochi is a Senior Economist at the International Center for Policy Studies. Working there, she has realized multiple projects at the intersection of academia and politics. She worked on topics as diverse as participatory dialogue among Ukrainian regions, quality of reforms in Ukraine and their intersectoral impact, hidden triggers of economic growth in Vysehrad countries and Ukraine, etc. Besides, she is a head of the NGO "Foundation for Youth Initiative". She would like to use the knowledge she acquired in the framework of the project "Science for democracy" to improve the quality of governance in Ukraine.

Diana Cucos, PhD, born in 1979, is a researcher at the Institute of Legal and Political Research of the Academy of Sciences of Moldova and a lecturer in international law at Moldova University of European Studies. In 2007, she was a trainee at the Directorate-General for External Relations of the European Commission. Her main areas of interest are international law, human rights and migration. She focuses in her academic work on the issue of labor migrants and their vulnerable legal situation. Recently, she had a post-doc fellowship at the University of Essex and in this context she is currently working on an article on the EU's recent political challenges.

Svetlana Dekina, PhD, born in1982, teaches at the National Polytechnic University in Odessa (Ukraine). She is the head of the Odessa Regional Council of Young Scientists that unites 2500 young scientists from all universities and research institutions in the Odessa region. In the framework of the Council she promotes science among young people by organizing events such as "Science Slam Odessa". She is interested in the issue of participation of NGOs in policy development, in NGOs-government relations and in fund-raising for NGOs.

Mkhitar Hayrapetyan, born in 1990, is a PhD candidate at the Institute of Oriental Studies at the National Academy of Sciences of Armenia. He is a member of the political party "Civil Contract" and a vice-president and board member in the Association of Young Politicians.
